Mike Bruner also went over bank account balances and the monthly revenue report.

#### **PARKS:**

Jacob Wagner said he would like to get moving on the dugouts at the park and the Legion would like to put up a flagpole at Loin's Park.

Andy Cotter let the Board know that Deputy Village Clerk Vannessa Weaver and Todd from Ruder's will be working to get new lights at the Softball Field through ComEd.

#### WATER AND SEWER:

Public Works employee Sean Culver spoke to the Board about the new water testing lab and said that we have a few local communities and well companies that have stated they will be using us.

Jeremy Bauer said that Tobey's should be done by the end of the week with the Park Road watermain project and will be seeding next spring.
